

The modeling includes 6-month rebalancing and an advisory fee of 1%, applied 0.25% each quarter. The start date for annualized returns and standard deviation is January 1999. The banchmark data has no advisory fees, is 100% stock and includes dividends. Blended Index is 48.25% S&P500, 18.75% Russell 2000, 27% MSCI World exUSA and 6% Global REIT with no fees.
